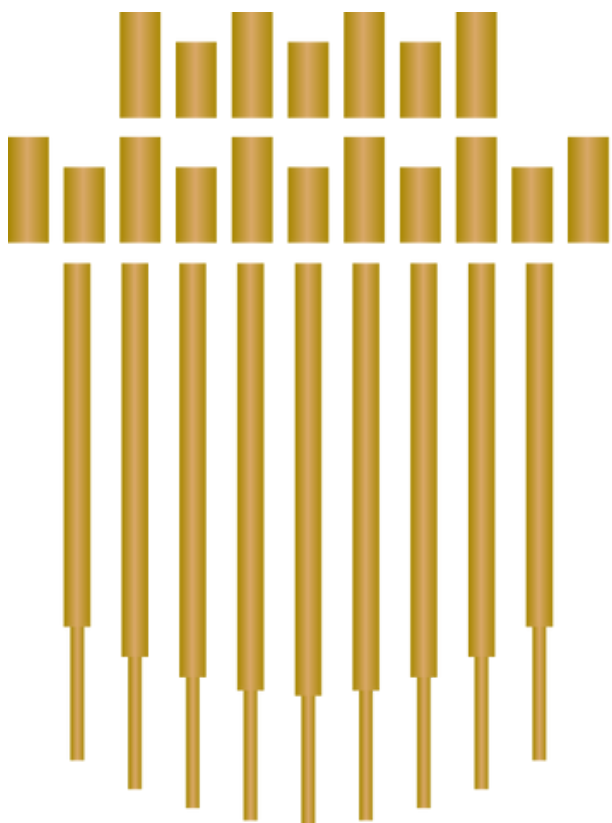

1. ONLINE REGISTRATION

Visit our website: www.tiwc.gr and create a user account to register your wines online.
If you have used the online entry system before, fill in your email and password to log in and register your wines/spirits. If this is the first time you are entering online, fill in your contact details to get a password and instructions.

2. SUBMITTING THE WINES

Submitting the wines is really easy. Just log in and go to the *Participation* tab, select the *Online Entry Form for Wines* or the *Online Entry Form for Spirits*, and fill out all the details of your sample.

(*) For each registered wine / spirit please attach one set of labels (front and back).

3. DEADLINE

The deadline for the registration of the wines is **05/02/2025**, and the delivery of samples is **February 10th, 2025**
No sample (of wine, spirit, registration form) can be accepted after the deadline.

4. PARTICIPATION COST

The early bird participation fee (VAT included) from 7th to 20th January 2025 is as follows:

105 € / sample for 1 - 4 samples
95 € / sample for 5 - 8 samples
90 € / sample for nine samples or more

The early bird participation fee (VAT included) from January 21 to February 5, 2025, is :

125 € / sample for 1 - 4 samples
115 € / sample for 5 - 8 samples
110 € / sample for nine samples or more

6. DISPATCH OF SAMPLES

6.1. Please send per registered wine (carriage paid):
5 commercially labeled bottles of 0,75L each.

6.2. Please send per registered spirit (carriage paid):
2 commercially labeled bottles of 0,5L each. In case of lower capacity bottles please send (at least) 1,00L in total.

(*) The wines should be sent as **“samples for competition, no commercial value”** and must be received by the organizers of the Competition no later than **February 10, 2025**.

(**) The organizers refuse all responsibility in case of late arrival of samples, total or partial loss during transport, physical, chemical and sensory alter- ations of samples due to temperature variations that may occur during transport. All charges of shipping, customs and taxes are in the responsi- bility of the participants who must settle the cost directly with the transport agents.
Products not complying with this procedure will be disqualified from taking part in the competition without refund of the registration fee. Refused sam- ples will not be returned to the sender.

(***) Withdrawal of samples from the competition is possible only before February 5, 2025. In any other case, the organizer is not obliged to refund the participation cost nor return the samples to the sender.

7. PRODUCTS PERMITTED TO COMPETE Wines and aromatized wine-based drinks The wine competition is open to all wines and aromatized wine-based drinks produced in conformity with the regulations of their country of origin, packaged in glass bottles of up to 2 liters (PDO, PGI, varietal, special wines e.t.c.). Boxed wines (Bag-In-Box) may participate in the competition and receive a final rating but they are excluded from the awards. Spirits - gin - ouzo and spirituous drinks of vitivinicultural origin The spirits competition is open to all spirituous beverages vitivinicultural origin and spirituous drinks of vitivinicultural origin produced in conformity with the regulations of their country of origin. Experimental samples (wines and spirits - gin - ouzo) Moreover, experimental samples (wines, aromatized wine-based drinks, spirits, gin, ouzo, spirituous drinks of vitivinicultural origin) can be tested and evaluated by juries. However, their rating is notified only to their producers and they are excluded from the awards. All products, apart from experimental samples, must be destined for sale and must be from a homogeneous batch of at least 1000 litres. On an exceptional basis, a reduced volume, of at least 100 litres, may be admitted upon justification of a particularly low production. 8. MEDALS, SPECIAL AWARDS The samples (wine/spirits), according to their final rating, receive the following awards: • Gold Medal • Silver Medal • Bronze Medal B. Best wine per Category The best wines of each category are re- tasted by all judges and award the distinction of the best wine of each category: • best white wine (category 1) • best rosé wine (category 2) • best red wine (category 3) • best dessert wine (category 4) • best sparkling wine (category 5) • best ‘retsina’ wine (category 6) For the award of the above distinctions it is necessary to participate in the competition at least five (5) samples of the same category C. Competition’s best wine - best spirit , ouzo & gin The best wines of each category, once they have earned a gold medal, are re- tasted by all judges and awarded: • The best wine of the competition The highest-grade spirits-ouzo-gin received the distinctions: • The Best Spirit of the Competition • The Best Ouzo of the Competition • The Best Gin of the Competition	D. Special awards The organizer will introduce special awards to the following categories, if at least 5 samples participate per category and their ratings corresponds at least to a bronze medal: a) best dry single variety Assyrtiko b) best dry single variety Malagousia c) best dry single variety Vidiano d) best dry single variety Xinisteri e) best dry single variety Moschofilero f) best dry single variety Savatiano - g)best dry red single variety Agiorgitiko - h)best dry red single variety Xinomavro i) best organic wine It should be noted that in case a wine, which is awarded as the best of its category, is part of the above special distinctions, it will also receive the special award. 9. MEDALS: STICKERS Medal stickers help your award-winning wine/spirit stand out and give consumers confidence when buying wines/spirits. As submitter of Thessaloniki Wine and Spirits Trophy, you have the possibility to order medal stickers for your awarded products. Alternatively, the award-winning companies may acquire the right to use the digital version of the awarded stickers into the labels of their award-winning products. Please note that the production and use of the stickers on the bottles without the Competition’s permission is not allowed. 10. PROGRAMME OF THE COMPETITION The competition will take place in Thessaloniki. Tasting sessions will be held from 25th until 27th February, 2025. The announcement of the results will be officially publicised on Friday 28 February, 2025 on the website www.tiwc.gr. 11. 12. CATEGORIES
The “Thessaloniki Wine and Spirits Trophy” is addressed to the products of the following categories:
1. White still wine (Dry-Medium dry-Medium-Orange Wine)
1.a White still wine / Dry
Wines containing not more than 4,5 g/L of sugar and have carbon dioxide overpressure under 0.5 bar (20°C)
1.b White still wine / Medium dry-Medium
Wines containing between 4.6 g/L to 45 g/L of sugar and have carbon dioxide overpressure under 0.5 bar (20°C)
1.c White still wine / Orange Wine
2. Rosé still wine (Dry-Medium dry- Medium)
2.a Rosé still wine / Dry
Wines containing not more than 4,5 g/L of sugar and have carbon dioxide overpressure under 0.5 bar (20°C)
2.b Rosé still wine / Medium dry-Medium
Wines containing between 4.6 g/L to 45 g/L of sugar and have carbon dioxide overpressure under 0.5 bar (20°C)
3. Red still wine (Dry-Medium dry- Medium)
3.a Red still wine / Dry
Wines containing not more than 4,5 g/L of sugar and have carbon dioxide overpressure under 0.5 bar (20°C)
3.b Red still wine / Medium dry-Medium
Wines containing between 4.6 g/L to 45 g/L of sugar and have carbon dioxide overpressure under 0.5 bar (20°C)

4. Dessert wine (still, sweet)
Wines containing more than 45 g/L of sugar
4.Naturally sweet wine
4.a. Naturally sweet wine - White
4.b.Naturally sweet wine - Rose
4.c. Naturally sweet wine - Red
4.Liqueur wines
4.d.Liqueur wines - White
4.e.Liqueur wines - Rose
4.f.Liqueur wines - Red
5. Sparkling wine (Semi Sparkling/Pearl - Sparkling)
5.a Semi Sparkling - White
5.b. Semi Sparkling - Rose
5.c. Semi Sparkling - Red
5.d. Sparkling wines - White
e. Sparkling wines - White
e. Sparkling wines - White

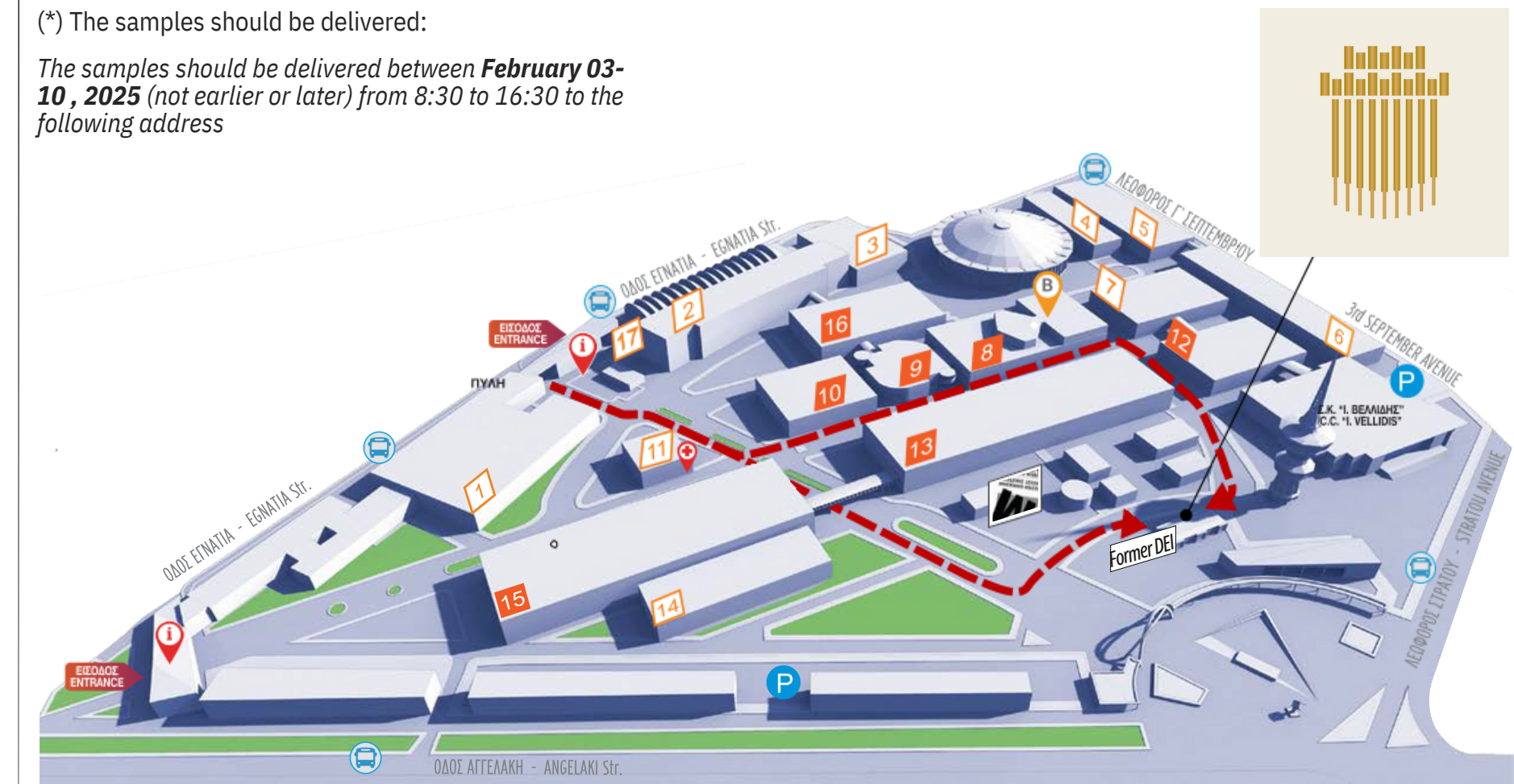

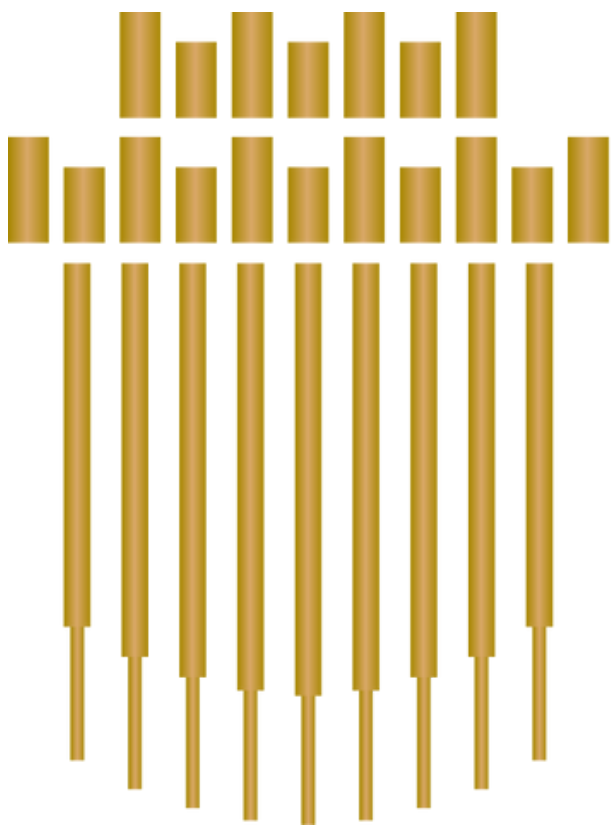
